3rd TPG B on LRC meeting and Seminar on recognition of alternative pathways 09 - 10 June 2022 France Education International, Sèvres

Structure and contents

The TPG B meeting will be preceded by a public seminar on alternative pathways that is conceived to supplement the activity of the group. The information shared during the **seminar will serve as theoretical input to stimulate the peer-support activity planned on the 10th of June 2022**. The **TPG B meeting** combines a mix of panel discussions to convey relevant/up-to-date information and peer-support activity to give the possibility to share national experiences, practices and perspectives to fulfil the LRC implementation.

Structure and contents of the events:

- **9 June (morning)**, the **public seminar** will offer an overview of national and international initiatives on recognition of alternative pathways with particular reference to Recognition of Prior Learning (RPL), recognition of non-traditional learning and micro-credentials, in line with the "[specific thematic indications](#)" prioritised by the TPG B members in the survey distributed in June 2021.
- **9 June (afternoon)**, the **TPG B meeting** panel discussion will present practices, tools and normative instruments to support recognition of qualifications from Ukraine. Updates on the TPG A and TPG C as well as on the EU funded project TPG-LRC CoRE will be provided.
- **10 June (afternoon)**, the **TPG B meeting** will be entirely devoted to the peer-support activity. Participants will be divided into smaller groups to work on two specific priorities 1) recognition of alternative pathways and 2) digitalisation for the recognition agenda. In each group, the discussion will start with the presentation of national experiences on the main topics. After the presentations, participants will be asked to share experiences, needs and perspectives to identify concrete steps toward the implementation of the two priorities.

In **preparation for the meeting**, participants are reminded to go over the [Action Plan for the TPG B](#).

During the working groups participants will be encouraged to share the progress to be achieved at national level by 2024 as included in the Action Plan for the group, as regard the two priorities addressed. Starting from that, they will have the occasion to find possible ways in which the peer support of the TPG B may contribute to the outlining of a roadmap towards the implementation of the two priorities.

As for the social activity, France Education International will kindly offer the tvisit of its historical building and the cocktail we will have afterwards.
