## General information

**Thematic group A is based on** Key Commitment 1 (a three-cycle system compatible with the overarching Qualifications Framework of the EHEA and first and second cycle degrees scaled by ECTS): TPG A includes 34 members and is co-chaired by Austria, Georgia, and Latvia.

### **Introduction and scope of the TPG A on QF**

The planned activities of the Working Group are in line with the Bologna Declaration of 1999 and its Communiqués', supporting the implementation of the Key Commitment 1- the implementation of the three-cycle Bachelor-Master-Doctorate degree structure.

The TPG A will specifically address the latest commitments made in the Rome Communiqué, which focuses on building an inclusive, innovative and inter-connected EHEA and reconfirm direction on fully implemented key commitments and usage of peers support methods.

Terms of reference of BICG for 21-24 emphasizes the value of peer support activities and importance to contribute the implementation process.

### ***Thematic orientations***

- TPG A working group will be working on the following thematic directions<sup>1</sup>:
- self-certification of the national qualification frameworks to the overarching Qualifications Framework of the EHEA;
- implementation of the ECTS User's Guide;
- short cycle higher education;
- multiple purposes and use of the qualifications frameworks by the stakeholders;
- study programmes outside of the Bologna three-cycle structure;
- relationship between the qualifications frameworks and quality assurance;
- micro-credentials.

### ***Working methodology***

Working methodology is based on mixed model having big group TPG A meetings and smaller working groups. Meetings will be organised face-to-face or online.

### ***Monitoring/outcomes***

Focus on the outcomes of the TPG, as the objectives of the countries are in the country pages. Effectiveness of the group to support the implementation of the key commitment, related to the Rome Communiqué. The countries will be asked to fill in country profiles until the mid of January. The TPG A work will be constantly monitored. The meeting minutes will be prepared after each meeting. Also, the key outcomes of the discussions will be captured in the meeting reports and shared with the TPG A members. The country related information on anticipated progress and achievements will be provided according to the country profile information and final report.
