

Draft proposal Terms of Reference for Working Group on Monitoring for the working period 2021-2024

<p>Composition</p> <p>A mixture of country representatives and interested stakeholder organisations (consultative members). Ideally the group should consist of no fewer than 10 members and no more than 15.</p>
<p>Purpose and/or outcome</p> <ul style="list-style-type: none"> ➤ To guide the preparation of the Bologna Process Implementation Report for 2024; ➤ To identify sources of reliable, comparable data relevant for the European Higher Education Area; ➤ to make further progress in improving structured and standardised monitoring of the EHEA; ➤ To ensure that accurate comparisons can be made between countries and that implementation and other changes are transparent within as well as between countries;
<p>Reference to the Paris Communiqué</p> <p><i>We call on the BFUG to address the actions and priorities indicated for the next decade with the overall purpose of creating a European Higher Education Area that fulfills our vision and achieves our goals by 2030.</i></p> <p>NB A sentence requesting an Implementation Report could be added</p>
<p>Specific tasks</p> <ul style="list-style-type: none"> ➤ To develop a proposal for the scope of the 2024 Bologna Process Implementation Report; ➤ To develop and agree the indicators to measure progress, and the data required for the 2024 report with the agreement of the BFUG; ➤ To develop suitable data collection material; ➤ To ensure that information is collected from all Bologna countries; ➤ To guide the drafting of the overall report for approval by the BFUG in advance of the 2024 Ministerial Conference;
<p>Reporting</p> <p><u>Minutes</u> of working group meetings will be made available by the Bologna Secretariat.</p> <p><u>BFUG should also receive regular reports and updates.</u></p> <p>To allow for good communication with BFUG as a whole and for the necessary consultations, progress reports should be made at each BFUG meeting. <u>More specifically, the set of key indicators measuring progress on Bologna actions shall be agreed with the BFUG.</u> In between BFUG meetings, updates can be circulated by the Bologna Secretariat via e-mail.</p> <p>The draft of the implementation report for 2024 will be presented and discussed at the BFUG meeting at the end of 2023.</p>
