#### Proposal of indicators for Principles and Guidelines

- Indicators on social dimension presented at the BFUG Meeting in Brno in November 2022 and at the BFUG Board Meeting in March 2023 > BFUG members were asked to provide feedback.
- The WG on Social Dimension received written comments by ENQA and the director of ENQA was at the WG SD meeting in Gent in February 2023.
- The BFUG Board in Sarajevo (March 2023) provided additional comments.
- Today we continue consultation with the ETUCE and E4 members (ENQA, EQAR, EUA, ESU).
- Goal: to prepare the new version of the document for the BFUG Meeting in Stockholm on 11-12 May 2023 > further comments will be provided in Stockholm



# Consultation related to:

#### Proposal of indicators for Principles and Guidelines

- The WG on Social Dimension would like to include indicators into the new version of the document 'Principles and Guidelines for Social Dimension'
- The new document of 'Principles and Guidelines for Social Dimension' should be adopted as an Annex to the Tirana Communique 2024.
  - Important policy objective in order to secure further development of the social dimension policy in the EHEA member states
  - New indicators will help creating national and institutional (university level) action plans for social dimension in HE.

# Updates

- Reformulate indicators related to the quality assurance, as agreed in Gent
  - ✓ Implemented
- Introduce 'explanatory descriptors' instead of sub-indicators and explain them in a narrative format. Make sure that the formulations are not written in a prescriptive way.
  - ✓ Implemented
  - ✓ Should we create descriptors for each indicator so that we have a consistent structure throughout the document?
- We decided not to create a system of monitoring, because our indicators and descriptors enable national and European authorities to create their systems of monitoring for the implementation of the principles for the social dimension > explain that in the narrative part.
  - ✓ Implemented


# **Updates**

    - ✔ Adoption paragraph: new
    - ✓ Executive summary: new
    - ✔ Definition of the social dimension: old
    - ✓ The new EHEA framework for the social dimension: new
    - ✓ Definition of the principles and guidelines: old
    - ✓ Definition of the indicators and explanatory descriptors: new
    - Policy alignment with previous EHEA documents: old
    - ✓ Positive impact of the social dimension on societies: old
- Proposal for the new (extended) title of the document: "Principles, Guidelines and Indicators to Strengthen the Social Dimension of Higher Education in the European Higher Education Area (PGI-2024)"
