Set up of Thematic Peer Group C on QA

2021-2024

- Chaired by 3 co-chairs: Belgium/Flemish Community, Romania and Kazakhstan
- **41 countries** take part: Albania, Armenia, Austria, Azerbaijan, Belgium/Flemish Community, Bosnia & Herzegovina, Bulgaria, Croatia, Cyprus, Czech Republic, Finland, France, Georgia, Germany, Greece, Holy See, Hungary, Iceland, Ireland, Italy, Kazakhstan, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Moldova, Montenegro, the Netherlands, North Macedonia, Norway, Poland, Romania, San Marino, Slovak Republic, Slovenia, Spain, Sweden, Switzerland, Ukraine, UK – Scotland
- **7 organisations:** EI-ETUCE, ENQA, EQAR, ESU, EUA, EURASHE, European Commission

Umbrella project: Implementation and innovation in Quality Assurance through peer learning (IMINQA)

2022-2025 (3 years) -> approved

- Total budget: max. 500,000 euro
- Partners: Ministry of Education and Training (BE/FC), ARACIS (RO), ENQA, EQAR
- Third co-chair (KZ) involved as expert
- Other experts: 1 from EUA, 1 from Romania

Umbrella project Thematic Peer Group C on QA: Implementation and innovation in Quality Assurance through peer learning (IMINQA)

2022-2025 (3 years) -> approved

- 7 WP's (6 content + 1 management)
 - Overall management -> start of project 1 May 2022
 - Organisation of TPG meetings (BE)
 - Staff mobility programme (BE)
 - 3 physical PLAs (EQAR)
 - 3 thematic WPs:
 - QA of Micro-credentials (ENQA)
 - QA of European Universities (BE)
 - Digitalisation of QA processes (RO)

WP 6 Working group on QA of European Universities

- Build further on the [EUNIQ](#) project
- Setup of a working group: peer learning to increase mutual awareness and understanding of QA expectations between the different stakeholders
- Analysis of legal obstacles in the participating countries in the WG to apply the EUniQ framework (July 2022-December 2022)
- Links with PLA2: Cross-border QA (CBQA) & QA of TNE and PLA3: European Approach for the QA of Joint Programmes, a preparatory analysis will be made

WP 6 Working group on QA of European Universities

- Based on the analysis of obstacles, 5 EHEA countries will be selected for a feasibility study (April 2023-October 2023) on how to implement the EuniQ framework in these countries.
- For this feasibility study, cooperation with national stakeholders will be set up through a national working group involving the European Universities involved in the respective countries. Each country involved will set up their own roadmap.
- Reporting back to the full working group during their third meeting.
- 2 small PLA's with the 5 selected EHEA countries in order to compare systems, learn from each other and come to a similar approach for the national work. (March 2023 & November 2023)

WP 6 Working group on QA of European Universities

Selection procedure:

- Maximum 30 participants, call for nomination of representatives
- Small survey (reason why joining, expertise, European Universities in the country, structured cooperation between national policy level and universities, ...)
- Analysis of applications and selection of applicants indicating different levels of developments and different expertise will be invited to the group
- **First online meeting on 17 June 2022**

WP 6 Working group on QA of European Universities

Results call:

- 19 countries (Albania, Armenia, Azerbaijan, Belgium/Flemish Community, Croatia, Cyprus, Finland, France, Georgia, Hungary, Italy, Kazakhstan, Lithuania, Malta, Norway, Romania, Slovenia, Sweden, The Netherlands)
- 6 organisations (EUA, ETUCE, ESU, European Commission, EQAR, ENQA)
- Survey results: mix of representatives of ministries and QA agencies, countries with high number of HEIs taking part in European Universities and with no participation yet, structured collaboration between national policy level and universities, ...
