#### Venue

The event will be taking place at the University POLITEHNICA of Bucharest, ROMANIA hosted by the Romanian Agency for Quality Assurance in Higher Education (ARACIS).

#### About the event

‘Cross-border Quality Assurance (CBQA) and Quality Assurance of Transnational Education (TNE)’ is the second of three Peer-Learning Activities (PLAs) on EHEA policy priorities in quality assurance organised by EQAR in the context of the ‘Implementation and Innovation in QA through Peer Learning’ (IMINQA) project<sup>1</sup>.

The aim of the PLAs is to catalyse exchange between national authorities and stakeholders on effective approaches in their openness to cross-border QA i.e., whether (some or all) higher education institutions can use a suitable EQAR-registered agency for their mandatory external quality assurance.

A thematic preparatory note will map the current state of play of countries’ openness to cross-border QA and the legal framework recognising external QA of foreign EQAR-registered QA agencies. The PLA will also reflect on key issues that need to be assured by the national system for the outgoing transnational education.

**Topic 1: Cross-Border Quality Assurance from an institutional perspective**

- What are the reasons for choosing a foreign QA agency?
- What are the obstacles/challenges for institutions when engaging in a CBQA?
- What are the conditions and specific requirements for the work of foreign QA agencies across the EHEA?

**Topic 2: Cross-Border Quality Assurance from a registered QA agency perspective**

- What is the spread and volume of cross-border QA activities across the EHEA?
- How are agencies ensuring that cross-border QA is beneficial to the local QA and HEI systems?
- What are the challenges/obstacles QA agencies are facing in carrying out cross-border QA?

**Topic 3: Quality Assurance of Transnational Education (TNE)**

- How is the national system assuring the quality of its outgoing TNE? What is the home-country's principle for TNE provision?
- How are QA agencies addressing the specific issue of TNE in its regular external QA of the (sending) higher education institution?
- Are there differences within the QA systems approaching HE provisions abroad vs. at home? If yes, what are these differences and what are the reasons for these differences?
- How are agencies ensuring the same level of quality provisions abroad vs at home? How are agencies avoiding the risk of QA being less stringent abroad (if the case)?
