## DRAFT ROADMAP TOWARDS THE MINISTERIAL CONFERENCE

#### 1. Aim

Progressing towards the EHEA Ministerial conference in Albania in 2024, there is a growing need to plan relevant steps, inputs and inform corresponding groups in order to allow their own planning. The following roadmap brings together several strands of activities which should feed into the proposed final documents to be discussed by the ministers in Tirana:

- A Drafting Committee (DC), the task of which is to prepare the draft communique reflecting also the work and outputs of various working groups (coordination groups, task forces, in the roadmap referred to as WGs)
- Coordination group on Global Policy Dialogue (CG GPD) which in charge of proposing the format of the Global Policy Forum and its Statement
- BFUG and BFUG Board, the executive structures to which the WGs report and which approve the final documents and decisions within the mandate given to them by the Ministers of the EHEA countries.

Two additional activities are included in the roadmap and require a special attention:

- The steps necessary for a call and identification of the host of the further ministerial conference, the date of which might be around year 2027, yet even this has to be still agreed within the BFUG;
- The role of the Task Force on the Review of the Rules and Regulations for the Governance of the European Higher Education Area (TF RR) which is proposed to be set up by the BFUG in November 2022 including a mandate to propose any systemic reforms within EHEA structures identified within the review of existing rules of procedures.

This document aims to provide a complex overview of the steps to be taken in relation to the development of the documents for the Ministerial Conference 2024 (Communiqué, Global Policy Forum statement), an overview of links and coordination between various EHEA working structures and proposes potential time frame. Yet, this is still a matter of discussion and coordination with all those engaged. Thus, the document should be considered as a working, living proposal, not a definite prescription.

A *Communiqué* is adopted at each Ministerial Conference that outlines decisions taken by the Ministers. The Drafting Committee prepares the Communiqué.

In connection with the Ministerial Conference, since 2009, a Bologna Policy Forum (BPF) has been organized, including countries and regional higher education organizations from around the world. Since 2020, this forum is renamed as Global Policy Forum, and Albania will host the next Global Policy Forum in 2024. The Coordination Group on Global Policy Dialogue prepares the *Statement* of the Global Policy Forum.

It is also desirable that the roadmap be regularly revised and updated at the upcoming BFUG meetings.

## 2. Background and context

## a) Drafting Committee

"Drafting committee is a task force of the BFUG, entrusted with the task to prepare the draft *Communique* for the upcoming Ministerial Conference. Drafting Committee is composed by the Cochairs of the last three semesters before the Ministerial Conference (Sweden, Bosnia & Herzegovina, Spain, Georgia, Belgium and Holy See) of the actual BFUG Work Plan, the Vice Chair and one consultative member. The consultative member is suggested by the consultative members and approved by the BFUG. The drafting committee agrees on the chairing arrangements during its first







meeting. The current Drafting Committee is foreseen to start its work on first semester of 2023, as the year that precedes the Ministerial Conference. Drafting Committee meets every time after the Board and BFUG meeting, as well as in other times of necessity, as accordingly decided beforehand. Drafting Committee prepares a roadmap of its work, which is forwarded to the BFUG for its approval." (Rules of Procedures 2021 – 2024)

The task for the BFUG in November 2022 is to agree on the member suggested by consultative members and confirm the set-up of the Drafting Committee. The Drafting Committee should agree on its chairing, develop its roadmap (using or modifying the following proposed schedule where necessary) and inform the relevant Working Groups about the schedule of their expected input (again proposed in the following roadmap).

## b) Coordination Group on Global Policy Dialogue

The CG GPF has its own terms of reference, yet should consider the overall schedule and interaction with the BFUG and any other EHEA structures. Considering the specific role of the Global Policy Forum in the preparation of its *Statement*, this group has been especially emphasized within the proposed roadmap.

# c) Task Force on the Review of the Rules and Regulations for the Governance of the European Higher Education Area (TF RR)

The Task Force is still a subject to the BFUG approval, including the detailed Terms of reference. However, while it focuses on a complete review of existing rules of procedures, there is a mandate to propose any systemic reforms within EHEA structures identified was opportune during their review. This may open a number of various questions which are likely hardly to be fully concluded within the remaining period – e.g. the role and position of the BFUG secretariat, issues of communication and desired engagement of the wider academic community, interaction with various partners. The BFUG might thus propose to the ministers to make decisions on further arrangements or giving the BFUG a mandate to proceed with further steps. Therefore, this new Task Force has been included under the issues of EHEA organization – together with a few notes on planning the call for the host of the next Ministerial conference.

## d) Host of the next Ministerial conference

The call for the host of the next Ministerial conference may be an item for the BFUG meeting in the spring 2023, still, the BFUG might discuss in November 2022 a few issues important for such call:

- Timing. The most likely time may be the first half of 2027, in recent years the periodicity of three years between the ministerial conferences has been most common (April 2009 in Leuven/Louvainla-Neuve, Belgium; April 2012 in Bucharest, Romania; May 2015 in Yerevan, Armenia; May 2018 in Paris, France; November 2020 in Rome, Italy (online)).
- Coordination. Considering the issues addressed above, there may be some uncertainty. The BFUG should therefore consider whether, within the next working periods, the model for the BFUG Secretariat accommodation and provision should continue to follow the current practice where the host of the upcoming ministerial conference hosts also the BFUG Secretariat. Or discuss any alternative provisions such as decoupling the two and ensuring more continuity in the secretariat provision, to be reflected within the upcoming call for the host.

## 3. Roadmap

The following table includes the proposed roadmap until the Ministerial Conference in Tirana, Albania in 2024. The dates included in the schedule are still provisional ones, proposed for consideration of a suitable timing of various steps, still to be confirmed by relevant BFUG co-chairs and working structures. Thus some of these are indicated in *italics*.
